2. Which data does Greyhound Sneltransport process and for what purpose

2.1 The following company, personal and cargo data can be processed:

- a) Company name, contact person's first and last name, date of birth,
- b) Company address details and possibly postal and / or private address (if necessary),
- c) Telephone number, e-mail address of the possibly different contact persons,
- d) Any Chamber of Commerce number, Driver's license number and / or Citizen Service Number,
- e) Any information about the cargo to be transported and / or documents and photos thereof.

2.2 Greyhound Sneltransport processes the companies, persons, persons referred to in 2.1

cargo data for the following purposes:

- a) your (company) name, address, telephone number and e-mail address and destination data used for contact about quotations, orders and invoices and the possible cancellation thereof;
- b) your (company) name, address details and telephone number are used for sending invitations and information about services and activities of Greyhound Fast Transport;
- c) your cargo data is used for quotations, orders and / or documents, such as eg. customs papers, ADR papers or other official documents.
- d) Any photos can be shared on Social Media, unless you state that this is not allowed.

3. Retention periods

Greyhound Sneltransport processes and stores your personal data until you request it delete the data. Subsequently, company, personal and cargo data will be destroyed.

4. Security measures and processors

4.1 To protect your next company, personal and cargo data, Greyhound has Express transport has taken appropriate technical and organizational measures.

4.2 Greyhound makes for the processing of company, personal and cargo data Express transport using third party services, so-called processor. Have with the processor we have a processor agreement.

5. Right of inspection, removal and requests for complaints

5.1 Through the owners of Greyhound Sneltransport you can submit a request for your company, - to view, receive, change or delete personal and cargo data. Greyhound Sneltransport will process your request and you within three months of receipt to inform

5.3 If you have complaints about the way Greyhound Sneltransport your company, persons, and processes cargo data or handles your requests, you can contact the Authority Personal data.
